Required Documentation to be Provided for Proof of Household Income

1. Copies of two (2) **pay stubs** from each income earning household member for each job held (must be within the last 30 days).
2. Copies of your filed 2008 Federal Income Tax Form 1040, 1040A or 1040EZ for each income earning household member. One form will be acceptable if income earning household members filed jointly.
3. If any member of the household is receiving income from the Department of Transitional Assistance (DTA), a letter from DTA, stating the monthly amount of assistance received from each family member, **MUST** accompany the Financial Aid application.

***Applications received without the above Proof of Household Income will be considered INCOMPLETE and returned to the applicant.**
